3.	Define 'Emoluments' and 'Average emoluments' for the purpose of pension. For what type of pension benefits does emoluments include D.A? (5)
4.	State and explain in brief any five classes of pension.(10)
5.	What is the minimun length of qualifying service required to receive monthly pension? How is the amount of pension determined? (1+4)
6.	What is the minimum length of qualifying service required to receive Retirement Gratuity? How is the amount determined? (1+4)
7.	What do you mean by Death Gratuity? What are the different rates of Death Gratuity depending upon the length of qualifying service of the deceased Government servant?(5)
8.	What are the conditions under which Retirement/Death Gratuity lapses to the Government? What is the Certificate required to be produced to receive Gratuity in such cases? (5)
9.	What is the rate of family pension payable to the family of a deceased Government servant, where the Government servant dies while in service -
	<ul><li>(a) after completion of one year continuous service but less than seven years continuous service.</li><li>(b) after completion of seven years continuous service.</li></ul>
	How long can the higher rate of Family pension be paid? (5)

- 12. What are the limitations on values of gifts that can be received by Government servants on the occasions of weddings, anniversaries, funerals etc. in excess of which report to the Government is necessary as stipulated by Rule 13 of the CCS (Conduct Rules), 1964?(5)

- 13. What are the minor penalties that can be imposed on a Government servant under the CCS(CCA) Rules? Explain, in your own words, the difference between 'Censure' and 'Warning'. (5)
- 14. What are the circumstances under which a Government servant may be placed under suspension? When is an order of suspension to be reviewed? (5)
- **15.** Answer the following in brief.
  - (a) Can major penalty proceedings end in the imposition of minor penalty? If so, how is the period of suspension to be treated?

  - (e) Which section of the Mizoram Police Act, 2011 barred every Police Officer from other employment or office of profit other than his duties as a Police?
  - (f) What is the punishment of a person on conviction for obstruction of Police Officer in police work?
  - (g) Which section of the Mizoram Police Act, 2011 prevents prosecution of Police Officer under the Mizoram Police Act, 2011 on certain conditions?
- 17. Fill in the blanks of any 5 (five) of the following with correct answers:
