2. What are the circumstances in which suspension of a Government servant comes to an end? (4)
3. Distinguish between Censure and warning. (3)
4. Name the 'least penalty' and the 'most extreme penalty' that can be imposed on a Government servant. What are the effects of these penalties on Government servant on whom such penalties are imposed? (2+2=4)
5. Can two statutory penalties under Rule 11 of the CCS(CCA) Rules, 1965 be imposed for a single lapse or offence committed by a Government servant? (5)
6. Mention any 4(four) types of cases which may merit action for imposing one of the major penalties. (4)
7. Mr. X is awarded punishment of 'Reduction to Lower stage in the time scale of pay for a period of three years without cumulative effect'. Discuss if it is a major or minor penalty. (4)
8. What are the orders against which no appeal lies under Rule 22 of CCS(CCA) Rules, 1965? (3)
9. (a) What is an ex-parte enquiry? How is it to be conducted? (5)

- (b) What is a 'Common Proceeding'? When it is called for and by whom it is conducted?

10. What is 'Strike' in the context of CCS (Conduct) Rules? Mention any 4(four) practices which amount to strike but often resorted to by Government Servants. (5)
11. Mention the employment or activities a Government servant may undertake without the previous sanction of the Government. (5)
12. What are the 'Dos' and 'Don'ts' for Government servants in regard to taking part in politics and elections? (6)
13. Discuss how to deal with communication received from public representatives or outside authorities relating to the service matters of the Government employees. (5)
14. What are the types of behaviour which may be termed as "Sexual harassment" under rule 3-C of the CCS(Conduct) Rules, 1964? (5)
15. Joint representation from Government servants in matters of common interest is to be viewed as subversive of discipline. Explain. (4)

 - (a) The CCS(Leave) Rules, 1972 is applicable to members of All India Services.
 - (b) Leave can be claimed as of right.
 - (c) No Government servant may be granted leave of any kind for a continuous period exceeding five years except with the sanction of the President.
 - (d) The leave at the credit of a Government servant who is dismissed or removed from service shall lapse.
 - (e) Different kinds of leave except casual leave can be availed in combination.
17. Write short note on any 2(two) of the following: (3×2=6)
 - (a) Maternity leave
 - (b) Leave not due
 - (b) Extraordinary leave
18. Mention any three conditions for which leave of one kind may be commuted into leave of another kind. (3)

 - (a) A Government servant applying Earned Leave for 9 days in continuation of 2 days Casual Leave granted to him.
 - (b) A Government servant on leave reports his return to duty 2 days before the expiry of the period of leave granted to him.
 - (c) A Government servant on leave reports his return to duty 7 days after the expiry of the period of earned leave granted to him.
