- (c) A Government servant on extraordinary leave is not entitled to any leave salary.
- (d) Special disability leave is admissible to all Government employees (permanent or temporary) who are disabled by any injury or illness incurred in the performance of his duty.
- (e) If the operation of any of these rules causes undue hardship in any particular case, any of the provision of these rules can be relaxed by the Ministry of Finance.
