For age proof, HSLC/HSSLC Certificates which clearly shows the candidate's date of birth shall be accepted. In the absence of date of birth in such certificates, the relevant documents issued by the competent authority may be accepted.

Provided that for advertisement made during calendar years of 2023 and 2024, the candidate must not have exceeded the age of 37 years on 1^{st} August of the particular calendar year.
