 - (d) What is an 'ex parte inquiry'?
 - (e) What is a 'Common Proceedings'?
 - (f) Can a Charged Officer take the assistance of a legal practitioner?
2. List out the Major Penalties and the Minor Penalties that can be imposed on a Government servant. **(9)**
3. Describe in detail the different stages in the procedure for imposing major penalty. **(12)**
4. Write notes on 'Report of arrest to superiors by Government servants'. **(4)**

- (c) No Government servant shall be granted leave of any kind for a continuous period exceeding _____ (three / five / seven) years.
- (d) The period of absence not covered by grant of leave shall have to be treated as _____ (dies non / leave without pay / deemed suspension) for all purposes.

PART- C FR & SR PART – II TRAVELLING ALLOWANCES (20 MARKS)

12. Answer **any five (5)** of the following questions. (5×2=10)
- (a) What is 'Mileage Allowance'?
- (b) When can a Government servant be said that he is on tour?
- (c) A Government servant whose headquarters was Aizawl died in Delhi while on tour and his body was brought home in a commercial flight at Government's expense. Comment.
- (d) A Government servant on tour to Imphal had to extend his stay for seven days on account of absence of any means of transport due to communal clash. Is he eligible to claim DA for the seven days of extended halt?
- (e) A Government servant who travelled in Government vehicle claimed TA which comprised of road mileage as well as Daily Allowances. Comment.
- (f) Can Daily Allowance be drawn on a holiday that occurs during a training course held outstation?
13. State whether the following statements are 'True' or 'False': (10×1=10)
- (a) A Government servant appearing for any obligatory departmental examination is entitled to T.A. for the journey to appear for the examination on not more than three occasions.
- (b) The time-limit for submission of claim for T.A. is 60 days from the date of completion of the journey.
- (c) Government servants who participate as sportsman / coach in sporting events of national / international tournament within India are eligible to travel by economy class by air.
- (d) The minimum Pay Level in the Pay Matrix for a Government servant to travel in taxi / own car is Pay Level 6.
- (e) The rate of Composite Transfer and Packing Grant is 80% of the last month's basic pay in case of transfer involving a change of station located at a distance of or more than 20 kms from each other.

- (f) When the Government servant on transfer uses taxi for journey, the road mileage will be one normal road mileage plus the numbers of family accompanying the Government servant.
- (g) A Government servant, who travels by a class lower than his entitlement, can draw the mileage allowance to which he would have been entitled, had he travelled by his entitled class.
- (h) TA as on transfer is admissible to a retiring Government servant in respect of journey of the Government servant and members of his family from the last station to his home town or to the place where they are to settle down permanently.
- (i) In case a Government servant in Pay Level 10 is transferred from one station to another in the interest of public services, he is entitled to claim transportation of personal effect at the rate of ¹ 50 per km.
- (j) TA on transfer is not admissible to a Government servant who was transferred on own request.
