Applications for the under mentioned vacant posts can be done online on the Mizoram Public Service Commission's online portal <https://mpsonline.mizoram.gov.in> till **03/11/2023**.

Applicants must verify that their applications are submitted after payment is done. Fees once paid will not be refunded. However, if due to technical error, more than one payment is made for the same post by the same applicant, the excess payment may be refunded.

*Persons with Disabilities are exempted from payment of application fees.*

1. **Name of Post** : *Jr. Grade of Mizoram Agriculture Service*
2. **Name of Department** : *Agriculture*
3. **Classification** : *Group 'A' (Gazetted)*
4. **No. of Posts** : *5 (Five)*
5. **Pay** : *Level 10 in the Pay Matrix (Rs.56,100 – Rs.1,24,500)*
6. **Eligibility Conditions** :

1) Educational Qualification:

- (i) B.Sc (Agri.) Degree and above from a recognized University.
- (ii) Knowledge of Mizo language at least up to Middle School Standard.

2) Age Limit:

A candidate must be between 18 years and 35 years of age on the last date of application. Upper age limit relaxation will be as per Notification No.A-12011/1/2019-P&AR (GSW) dt.3.6.2019 (published in the Mizoram Gazette Extraordinary, Issue No. 375 dt.10.6.2019) as amended from time to time. For age proof, HSLC/HSSLC Certificates which clearly shows the candidate's date of birth shall be accepted. In the absence of date of birth in such certificates, the relevant documents issued by the competent authority may be accepted.

*Provided that the upper age limit in all recruitment rules/service rules for Group 'A', 'B', 'C' and 'D' posts under the Government of Mizoram where upper age limit prescribed for direct recruitment is 35 (thirty-five) years shall be 37 (thirty-seven) years for direct recruitments in various posts under the Government of Mizoram for advertisements likely to be made after the commencement of these rules during the Calendar years of 2023 and 2024*

7. **Disqualification** :

- i) Canvassing by a candidate directly or indirectly will disqualify his/her candidature.
- ii) Particulars/Details to be mentioned in the application should be completely and correctly stated. Any application not specifying the required information of a concerned candidate shall be liable to be rejected.
- iii) Any candidate who, on verification at any stage of the recruitment process, does not fulfil any of the eligibility conditions, will be disqualified.

**Note 1:** *The crucial date for determining the age limit of candidates shall be the closing date of receipt of applications from candidates.*

**Note 2 :** *Candidates whose final examination for a degree of recognized University has been held and the results are yet to be declared in due course may be allowed to appear in the written examination. All candidates who are declared qualified in the written examination will be required to produce proof of passing the requisite examination on or before the date of personal interview.*

**Note 3 :** In exceptional cases, the Mizoram Public Service Commission or the Mizoram Subordinate Services Selection Board or the Department conducting the examination may treat a candidate who does not have any of the foregoing qualification as a qualified candidate provided that he/she has passed examination conducted by other institution the standard of which in the opinion of the Mizoram Public Service Commission or the Mizoram Subordinate Services Selection Board or the Department justifies his/her admission to the examination.

**Note 4 :** Candidates possessing professional and technical qualifications which are recognized by Government as equivalent to professional and technical degree would also be eligible for admission to the examination.

Government servants will have to apply through proper channel.
