# II. For Grade-V of MSCS (Cooperative Audit Officer) under CooperationDepartment:

(i) Educational Qualification:

Bachelor's Degree from a recognized University.

- (ii) Candidates whose final examination for a degree of recognized University has been held and the results are yet to be declared in due course may be allowed to appear in the written examination. All candidates who are declared qualified in the written examination will be required to produce proof of passing the requisite examination on or before the date of personal interview.
- (iii) In exceptional cases, the Mizoram Public Service Commission may treat a candidate who does not have any of the foregoing qualification as a qualified candidate provided that he/she has passed examination conducted by other institution, the standard of which in the opinion of the Mizoram Public Service Commission justified his/her admission to the examination.
- (iv) Candidates possessing professional and technical qualifications which are recognized by Government as equivalent to professional and technical degree would also be eligible for admission to the examination.

# **III. Computer Proficiency:**

Computer Proficiency as prescribed by the Mizoram Group 'A', 'B' and 'C' posts Service/Recruitment (Amendment) Rules, 2016 and 2023 notified vide No. A.12034/1/2015-P&AR (GSW) dated 10.07.2019 and No. A.12018/31/2020-P&AR (GSW) dated 10.03.2023 respectively. (Details can be seen on MPSC website)

#### IV. Age Limit:

A candidate must not be less than 18 years and not more than 35 years of age on the last date of application. Upper age limit relaxation will be as per Notification No.A-12011/1/2019-P&AR(GSW) dt.3.6.2019 (published in the Mizoram Gazette Extraordinary, Issue No. 375 dt.10.6.2019) as amended from time to time. For age proof, HSLC/HSSLC Certificates which clearly shows the candidate's date of birth shall be accepted. In the absence of date of birth in such certificates, the relevant documents issued by the competent authority may be accepted.

Provided that the upper age limit in all recruitment rules/service rules for Group 'A', 'B', 'C' and 'D' posts under the Government of Mizoram where upper age limit prescribed for direct recruitment is 35 (thirty-five) years shall be 37 (thirty-seven) years for direct recruitments in various posts under the Government of Mizoram for advertisements likely to be made after the commencement of these rules during the Calendar years of 2023 and 2024.
