The Government of Mizoram had notified the Mizoram Recruitment/Service (Amendment) Rules, 2024 vide *No.A-11019/1/2021-P&AR (GSW) dt. 9<sup>th</sup> April, 2024* which mandates that for all recruitments to Group 'A', 'B', 'C' and 'D' under the Government of Mizoram, a candidate must achieve a minimum score in the qualifying test of Mizo Language Proficiency as prescribed by the Government from time to time.

In pursuance of the Mizoram Recruitment/Service (Amendment) Rules, 2024, for all advertisements floated on or after 09.04.2024, the Mizoram Public Service Commission will conduct **Mizo Language Proficiency Test (Qualifying Test) (MLP Test)** for all Direct Recruitments conducted by the Commission.

**Note:** 

- 1. A candidate who studied Mizo subject in Class-X standard (HSLC) or above within Mizoram or who opted for Mizo subject as MIL outside Mizoram is exempted from taking the qualifying test paper.
- 2. Candidates who fail to achieve minimum score in the MLP Test and do not have proof of MLP will be disqualified even if they have been shortlisted for Screening of Documents.

### **NOTIFICATION**

**No. A-11019/1/2021-P&AR(GSW), the 9<sup>th</sup> April, 2024:** In exercise of the powers conferred by the proviso to article 309 of the Constitution, the Governor of Mizoram hereby makes the following rules to amend the recruitment rules/service rules under the Government of Mizoram, namely;

- Short title and Commencement.-
- (1) These rules may be called the Mizoram Recruitment/Service (Amendment) Rules, 2024.
- (2) They shall come into force from the date of their publication in the Official Gazette.
- 2. Application.-
- (1) These rules shall be applicable to all the recruitment rules/service rules of Group 'A, 'B, 'C,' and 'D' under the Government of Mizoram.
- Amendment of recruitment rules.-

In all recruitment rules as specified in rule 2 of these rules, the entries 'Mizo Language Proficiency of at least Middle School Standard' in the column of educational and other qualifications in the Schedule shall be substituted as follows, namely;

" A candidate must achieve a minimum score in the qualifying test of Mizo Language Proficiency as prescribed by the government from time to time."

4. Amendment of service rules.-

In all service rules as specified in rule 2 of these rules, the entries 'Mizo Language Proficiency of at least Middle School Standard' in the column of educational and other qualifications in the Schedule shall be substituted as follows, namely;

" A candidate must achieve a minimum score in the qualifying test of Mizo Language Proficiency as prescribed by the government from time to time."

5. In all service/recruitment rules specified in rule 2 of these rules, the following shall be inserted, namely:-

#### SYLLABUS FOR MIZO LANGUAGE PROFICIENCY TEST (QUALIFYING TEST)

Duration : 2 hours Full mark : 50 Qualifying mark/Pass mark : 20

1. Essay writing : 10 marks

(Candidate will choose one topic from three given topics with word limit of not less than 200 words)

Letter writing : 10 marks
 Comprehension : 10 marks
 (Question will be set in Middle School standard)

4. Poetry : 10 marks

(Objective Type and short answer type questions will be set in Middle School standard. Marks for each question will range from 1 to 3 marks)

5. Grammar : 5 marks
(Question will be set in Middle School standard)
6. Mizo Thufing and Tawng Upa : 5 marks

(Question will be set in Middle School standard)

**Note 1:** A candidate who studied Mizo subject in Class-X standard (HSLC) or above within Mizoram or who opted for Mizo subject as MIL outside Mizoram is exempted from taking the qualifying test paper. **Note 2:** Questions and answers shall be written in Mizo only. Answers written partly in one language and partly in another language shall not be evaluated and awarded zero marks.
