THE COMMISSION AND ITS COMPOSITION

The Mizoram Public Service Commission, constituted in pursuance of Article 315 of the Constitution of India has been functioning with its headquarters at Aizawl since the 1st May, 1991.

The Commission initially started functioning from a rented building at Mission Veng, Aizawl from May 1991. The Commission shifted its office to a rented building at Saron Veng, Aizawl from April, 1995. Thereafter, the Commission had its own building at MINECO, Khatla, Aizawl and has been functioning from its own Office from 01.04.2008 onwards. The Commission also had a new Examination Hall building in the Office Complex at MINECO. The Examination Hall, having a capacity of 800 seats was inaugurated and functional since 01.10.2011.

Pu Lalramthanga Tochhong, IA&AS (Retd) left the post of Chairman of the Commission on 19.06.2022 on attaining the age of 62. Pu J.C. Ramthanga IAS (Retd.) joined the post of Chairman of the Commission on 21.06.2022.




BUDGET ALLOCATION, RECEIPT & EXPENDITURE

The Mizoram Public Service Commission is provided funds in the form of Charged Expenditures as provided under **Article 322** of the Constitution of India. Apart from the funds allocated in the original demands for grants in the Annual Budget, the additional requirement of funds are provided by Finance Department, Government of Mizoram.

During the year 2022 - 2023, ₹ 912.43 lakh was allocated to the Mizoram Public Service Commission against which the Commission incurred an expenditure of ₹ 911.13 lakh.

Revenue Receipts of the Commission are mainly receipts on account of examination fees, sale of application forms, rental charges of MPSC Examination Hall, receipts on account of condemned materials, etc. ₹ 12.73 lakh was collected as revenue receipt during the year.

FUNCTIONS OF THE COMMISSION

As per provisions under Article 320 of the Constitution of India, it is the duty of the Commission to conduct examinations for appointment to various services and posts in the State and to advise the Government on all matters relating to methods of recruitment to Civil Services, and to give advice to the Government in any matter which the Governor may refer to the Commission, as well as principles to be followed in making such appointments, promotions and transfers from one service to another. The Commission is also to be consulted by the Government before taking final decision on disciplinary matters in respect of persons serving under the State Government in civil capacity. The Commission's advice is also to be sought regarding any claim filed by a Government servant for payment of legal expenses incurred by him / her in defending himself / herself in any legal proceedings instituted against him / her for acts done in the execution of his/her duties as also on the award of compensation for injuries sustained by a Government servant in his / her civil capacity.

As per the provisions of the Mizoram Public Service Commission (Limitation of Functions) Regulations, 1994, the Commission is to be consulted by the Government on the following matters:

- a) Appointment to a post carrying the scale of pay of ₹2900.00 per month and above.
- b) Principles to be followed in making of promotions or on the suitability of candidates for promotion by the Governor.

However, the Mizoram Public Service Commission (Limitations of Functions) Regulations 1994 (hereinafter referred to as the Principal Regulations) was amended by the Government from time to time, and the latest amendment in respect of Direct Recruitment was notified in the Mizoram Gazetted under Memo No. A. 12017/2/2003-P&AR (GSW) dt.17.06.2019. Thus, the existing Regulations under 3(a) were substituted and it shall not be necessary to consult the Commission when an appointment is to be made by the Governor or by any authority other than the Governor in respect of Group 'B'(Non-Gazetted),Group 'C' and Group 'D' posts. Proviso to this Regulations exempt the recruitment of all posts of Zoram Medical College from consultation with the Commission. Again, some provisions in the Principal Regulation were omitted and new provisions were inserted in this amendment Regulations.

Again, by virtue of the provisions of the Office Memorandum issued by the State Government in the Department of Personnel & Administrative Reforms (General Service Wing)vide No.A.31011/1/2019 -P&AR(GSW) dated 14th June, 2019, it became the duty of the Commission to give advice on the matter of confirmation to service, or extension of probation period to a person on probation whose recruitment were under the purview of the Commission.

The works of the Commission for the period under report could be summarised as under:

- 1) Recruitment to the service or post of all Gazetted posts under the State Government.
- 2) Promotion from lower post to higher post/grade, including through Limited Departmental Examination of all Gazetted posts under the State Government.
- 3) To give advice in all matters relating to the method of recruitment and on the principles to be followed in making appointment to all Gazetted posts under the State Government.
- 4) To give advice on disciplinary cases.
- 5) To give advice on the matter of confirmation to service, or extension of probation period to a person on probation whose recruitment were under the purview of the Commission.
- 6) Any claim payable out of the Consolidated Fund of the State to a person serving under the Government in a civil capacity towards the cost incurred by him/her in defending legal proceedings instituted against him/her for acts done or purported to have been done in execution of his/her duty.
- 7) Any claim for the award of a pension in respect of injuries sustained by a person while serving under the State Government, in a civil capacity and any question as to the amount of any such award.

CHAPTER 5 DIRECT RECRUITMENT

One of the important functions of the State Public Service Commission is to conduct direct recruitment to various services and posts under the Government of Mizoram. The process of direct recruitment to various Group 'A' and 'B'(Gazetted) posts commenced with the formal notification of vacancies for direct recruitment by the Cadre Authorities/Departments to the Commission. Thereafter, the Commission issued advertisements, followed by the conduct of examinations consisting of written examination, and personal interview. The results are then published by the Commission, and the list of successful candidates duly recommended by the Commission are then forwarded to the concerned Cadre Authorities/Departments.

The Mizoram Civil Services (Combined Competitive) Examination

The main recruitment examination conducted by the Commission is the Mizoram Civil Services (Combined Competitive) Examination through which Officers are recruited to the Mizoram Civil Service (MCS), the Mizoram Police Service (MPS), the Mizoram Finance & Accounts Service (MF&AS) and the Mizoram Information Service (MIS). Conduct of the Mizoram Civil Services (Combined Competitive) Examination commences from the year 2013. The MCS (Combined Competitive Examination) Rules, 2020 notified by the Government laid down the process of recruitment, and the process of annual recruitment with a calendar of recruitment is clearly laid down in the Rules. Recruitment to the 4 major Services is conducted annually by the Commission through the Preliminary Examination, and the Main Examination consisting of written examination and personal interview.

The Mizoram Civil Services (Combined Competitive Examination), 2021, which was initiated in the year 2021 was completed during the year, and the result was finally published on 30.09.2022. A total of 35 successful candidates were recommended for appointment to the 4 Services as shown below:-

Mizoram Civil Service - 15
 Mizoram Police Service - 8
 Mizoram Finance & Account Service - 8
 Mizoram Information Service - 4

The Commission established examination centres in the 7 Districts outside Aizawl namely-Lunglei, Siaha, Lawngtlai, Kolasib, Mamit, Champhai and Serchhip. The Commission conducts The Mizoram Civil Services (Combined Competitive) (Preliminary Examination) in all the 7 centres in the Districts by utilizing the services of the offices of the Deputy Commissioners and the concerned authorities of the institutions identified for examination centres.

Direct Recruitment for Other Services/Posts

The process of direct recruitment broadly follows the calendar year, and hence the process of direct recruitment may not be completed during the same fiscal year. As a results, some of the posts advertised during the previous years but had not been completed were then carried forward to the following year. Recruitments taken up during the year are as below-

- i) There are 2 direct recruitment which were advertised during 2021-2022, for which the process of recruitment had been carried forward and completed during the year 2022-23. The Total No. of Posts for these recruitments was 5 posts.
- ii) There are 12 Services/Posts for which vacancies for direct recruitment were notified by the Cadre Authorities/Departments to the Commission. The Commission issued advertisements for these 12 Services/Posts during the year. The total No. of these posts for direct recruitments are 79 posts.

Direct recruitments to Services/Posts are governed by the relevant Service Rules, Recruitment Rules, or other Rules/Regulations governing the processes of recruitment. For other matters, the provisions of the MPSC Examination Guidelines govern the operational details in the conduct of examinations for direct recruitments.

Recruitment for Persons with Benchmark Disabilities (PwBD)

The Commission had been taking efforts to provide special arrangement for Persons with benchmark disabilities as duly provided in the revelant Act and Rules, and other instructions issued by the Government of India, and the Government of Mizoram from time to time.

Proposed new Recruitment for Services/Posts

In order to streamline the process of direct recruitments to Services and Posts under the Government of Mizoram, the Commission worked out a system for introduction of annual recruitment by conducting the annual examination for the following Services/Posts under the Government of Mizoram, namely-

- i) Mizoram Engineering Service
- ii) Mizoram Health Service
- iii) Group 'B' (Gazetted) General Services


The proposals are for conduct of combined/simultaneous examinations on annual basis. Annual Calender of recruitment had also been drawn up so that a system is in place for a more structured direct recruitment system in the Commission. The Commission had been in close consultation with the Government of Mizoram in this regard.



PROMOTION, INDUCTION AND LIMITED DEPARTMENTAL EXAMINATIONS

This Chapter highlights the works of the Commission in various matters relating to Promotion to higher grades, Induction to Services/Posts, and Limited Departmental Examinations conducted by the Commission during the year.

(A) PROMOTION

Promotion to higher grades / posts in the Government is done with recommendations of the duly constituted Departmental Promotion Committees. Thus, all cases of promotions in the Group 'A' and Group 'B' (Gazetted) Post are done only on the recommendations of the Mizoram Public Service Commission.

During the year 2022-23, various proposals were received by the Commission for consideration of the DPC. These proposals were then examined in line with relevant Services Rules and the Recruitment Rules governing such Services/Posts, and the Comprehensive Instructions notified by the Government of Mizoram vide No. 32012/1/2011-P&AR (GSW) dt. 28.02.2018

DPC Meetings were thus convened in the Commission throughout the year to consider all such cases of promotions under different Departments for Services/Posts. The detail in respect of proposal for promotion consider by the Commission during the year are as follow:

(B) INDUCTION

There are some services in which the relevant Service Rules/Recruitment Rules provide for recruitment through the process of induction. There are 2 Services/Posts which have induction as one of the methods of recruitment under the Government of Mizoram.

- 1) The Mizoram Civil Service, and
- 2) The Mizoram Finance & Accounts Service

During the year, induction to the following services was carried out by the Commission, namely –

1) Mizoram Civil Service – 3 posts

(C) LIMITED DEPARTMENTAL EXAMINATION

There are various Services/Posts in which the Services Rules/Recruitment Rules provide for promotion through Limited Department Examination (LDE). For such Services/Posts, the Commission conduct Examination for the eligible candidates.

There are around 15 Services/Posts in Group 'A' and 'B' (Gazetted) for which the relevant Rules provide for conduct of Limited Departmental Examinations under the Government of Mizoram.

The Commission received proposals from various Departments/Cadre for conducting Limited Departmental Examinations for promotions to higher grade. Accordingly, 13 (thirteen) Limited Departmental Examinations were conducted during the period. Based on the results of the examinations, the Commission published the results and made recommendations to the respective Departments/Cadre Authorities.

REGULARIZATION, ABSORPTION AND CONFIRMATION

(A) REGULARIZATION

The Commission has the responsibility of examining the proposals for regularization of contract employees to the Group 'A' and 'B' (Gazetted) posts under the Government of Mizoram. The Proposals for regularization were then placed for consideration of the DPC Meetings for making recommendations for their regularization.

(C) CONFIRMATION

The Government of Mizoram issued a comprehensive instructions in its Office Memorandum No. A-31011/1/2019-P&AR(GSW) dt.14.06.2019 regulating the process of confirmation of employees under the Government of Mizoram. Based on this, various proposals for confirmation of Group 'A' and 'B' (Gazetted) Officers were placed for consideration of the DPC in the Commission. During the year, proposals for confirmation of Officers considered by the Commission are as below-

DEPARTMENTAL EXAMINATIONS

Services Rules and Recruitment Rules of some Services/Posts provided for departmental examinations to be passed by the new appointees during the period of their probation. The Commission is mandated to conduct departmental examinations for such Officers. The following Services/Posts have such provisions of mandatory departmental examinations –

- 1) Junior Grade of Mizoram Civil Service
- 2) Junior Grade of Mizoram Police Service
- 3) Junior Grade of Mizoram Finance & Accounts Service

Again, the Junior Grade of Mizoram Engineering Service and Inspector of Excise & Narcotics are mandated by their respective services rules/recruitment rules to pass departmental examination conducted by the Commission as a pre-requisite eligibility criteria for promotion to next higher grade in the Services.

The Commission normally conducts 2 departmental examinations in a calendar year, and normally in the months of June and December.

SERVICE RULES & RECRUITMENT RULES

The Constitution of India provides that the State Public Service Commission shall be consulted on all matters relating to methods of recruitment to civil services and for civil posts. Thus, the Commission had been consulted on all such matters relating to the Service Rules, Recruitment Rules, and other regulations governing recruitment and service conditions to various services and posts belong to Group 'A' and 'B' (Gazetted).

When such proposals for Service Rules, Recruitment Rules and other Regulations are considered by the Government, the Commission is required to be consulted on such proposals. Thus, the Government refers all such proposals to the Commission for examination and for giving comments on the draft proposals.

Besides, when proposals for relaxation of Service Rules/Recruitment Rules and other relevant provisions are considered by the Government, the Commission is consulted for giving advice and comments.

During the year 2022-23, there were a total of 13 (thirteen) proposals referred to the Commission in regard to framing and amendment of various Service Rules/Recruitment Rules from the Government for vetting. All those cases were examined and comments of the Commission were conveyed to the Government.

During the year 2022-2023, there were 27 cases referred to the Commission on relaxation of Service/Recruitment Rules. All such cases were examined, and advice of the Commission were conveyed to the Government.

DISCIPLINARY MATTERS

As enumerated in Article 320 (3) (c) of the Constitution of India, the Commission is to be consulted in matters regarding imposition of penalties on Government servants. As per the Limitation of Functions made by the Government, the Commission's mandate is confined to Services/Posts under Group 'A' and Group 'B' (Gazetted) under the Government of Mizoram and in respect of appeal or memorial to the Governor. During the period under report, the Commission received disciplinary cases from the Government of Mizoram as below:

- 1) No. of Disciplinary Cases referred to the Commission 2

The Commission completed examination of all such cases referred to it by the Government during the year.

CHAPTER 11

NON-ACCEPTANCE OF COMMISSION'S ADVICE

There were no instances of non-acceptance of the Commission's Recommendations or Advice by the Government during the year.

POLICY FRAMEWORK

(A) DIRECT RECRUITMENT:

As already indicated in the previous chapter, conduct of various direct recruitment examinations is one of the major tasks of the State Public Service Commission. During the year, the Commission had taken up various policy initiatives in the process of direct recruitment, which are indicated below.

The Mizoram Public Service Commission (Examination) Guidelines, 2023

The method of recruitment, eligibility criteria and other conditions are generally provided in the Recruitment Rules or Regulations. In addition to these rules and regulations, the Commission devised and compiled its own Guidelines called "The Mizoram Public Service Commission (Conduct Of Examinations) Guidelines". The provisions in the services rules/recruitment rules and other regulations govern the process of direct recruitment to services/posts. In consonance with these statutory rules and regulations, the Commission laid down these Guidelines to provide the essential details for conduct of the examination. The framework contained in these Guidelines lays down a system for fair and objective assessment of candidate's suitability for selection by way of recruitment through written examination and personal interview. In certain cases direct recruitment is carried out through screening and interview as well as by personal interview only. The criteria, procedure and methods of selections are constantly reviewed and amended and incorporated in these Guidelines.

The existing Guidelines notified in 2013 had already been amended over time and different notifications were issued during the last ten years. The Commission had taken efforts to consolidate all these amendments, and also to carry out extensive revision of the existing Guidelines to meet the requirements recruitment examinations. The Revised Examination Guidelines was finally notified on 02.03.2023.

The MPSC Evaluation and Scrutiny Guidelines, 2022

The MPSC never has a separate guideline for regulating the processes of evaluation and scrutiny in the examinations conducted by it. The Commission had taken efforts to do the same by drafting the new Guidelines, and after due approval by the Commission's meeting, the same was notified on 10.01.2023.

This is the first ever such Guidelines issued by the Commission for regulating the evaluation and scrutiny in the examinations and is considered an important landmark in the conduct of examinations. This new Guidelines is an important development in the recruitment process, and the new system is expected to streamline the process of evaluation and scrutiny in the examinations conducted by the MPSC.

(B) GUIDELINES FOR INDUCTION TO SERVICES/POSTS

The Commission is mandated to carry out recruitment to services/posts through the method of induction, as some of the services/posts have such provisions in their service rules. The Commission carefully examined such cases, and the Regulations that govern the process of such induction so that when the actual process is carried out as per the provisions of the rules, and there is a proper and transparent system of assessment of the candidates.

Accordingly, the Commission had taken up examination of such Regulations, and in the absence of a complete process of assessment, the Commission had to devise and notify the Guidelines to supplement the Rules, or the Regulations governing such induction. In the case of Induction to the Mizoram Civil Service, the Commission had earlier notified the "The Mizoram Public Service Commission (Induction to Junior Grade of Mizoram Civil Service) Guidelines, 2022" on 14.03.2022. Again, the Commission notified "The Mizoram Public Service Commission (Induction to Junior Grade of Mizoram Finance & Accounts Service – Evaluation of Seniority and PAR) Guidelines, 2022" on 13.12.2022 to supplement the existing Regulations for induction to MF&AS.

(C) FRAMEWORK FOR LIMITED DEPARTMENTAL EXAMINATIONS:

The Commission conducts various limited departmental examinations under the provisions of relevant service/recruitment rules under the Government of Mizoram. During the year, the Commission carried out an objective study of the various provisions of the Rules and Regulations governing such limited departmental examinations for Group 'A' and 'B' (Gazetted) services/posts under the Government of Mizoram.

After thorough study, the Commission observed that there are some of the provisions in the existing Rules and Regulations that need to be amended so that the process is streamlined, and a more uniform system can be put in place. Besides, the Commission felt it expedient that the examinations for LDE be conducted by laying down the broad examination framework starting from the notification of vacancies, till publication of the result of the examination. The broad framework as laid down by the Commission will be put in place from the year 2023-24 onwards.

OTHER MATTERS

(A) COURT CASES:

The decisions of the Commission were challenged in the Hon'ble High Court on 4 (four) occasions during the period under report and one case was finalised in favour of the Commission. The Commission has its own Standing Counsel to represent the Commission in various litigations against it.

(B) VISIT BY THE CHAIRMAN/MEMBERS OF THE COMMISSION

During the year, the following visits by the Chairman and Members of the Commission took place –

1) Pu Lalramthanga Tochhawng, then Chairman attended the 23rd National Conference of Chairpersons of State PSCs held at Thiruvananthapuram, Kerala during 15th & 16th April, 2022.

(C) VISITS/TRAININGS/TOURS OF OFFICERS OF MPSC

During the year, the Officers of the Commission attended various trainings and performed tours in the form of visits as under:

- 1) Pu Vanlalmawia, Secretary attended the Workshop on Disciplinary Proceedings conducted by the Union Public Service Commission for State PSCs at UPSC Office, New Delhi on 07.09.2022.
- 2) Pu Lalsawmzuala, Assistant Controller of Examinations attended the Workshop conducted by the Union Public Service Commission on Recruitment Rules at UPSC Office, New Delhi on 10-11November, 2022.
- 3) The Commission sent a Team consisting of Pu Lalsawmzuala, ACE, Pu R. Lalthantluanga Assistant (DR) and Pu David Lalfakawma DEO (Confidential), to visit and study various important matters of the PSCs of neighbouring States. They visited the PSCs of the States of Assam, Tripura and Manipur during 27.11.2022 to 4.12.2022. The Team's visit and learning of cross-experiences will greatly benefit the Mizoram Public Service Commission in the years to come.

(D) WORKS UNDER THE RTI ACT, 2005

The Commission, being a Public Authority, is accountable under the provisions of the RTI Act, 2005. Thus, various provisions relating to the public authorities are duly

complied by the Commission. The following Officers were designated as public authorities during the year:

Suo Moto Disclosures

As mandated under Section 4 of the Right to Information Act, 2005 the Commission published the required information in the form of *Suo Moto Disclosures* and the same is displayed in the Website of the Commission.

Information sought under the Act – Offline Applications and Appeals

During the year, 172 applications through off-line mode were received by the SPIO and were disposed within the prescribed time by the SPIO. There was 1 (one) Appeal in off-line mode to the Departmental Appellate Authority.

Online Portal and Online Applications/Appeals

With the introduction of Online RTI Portal by the Government of Mizoram and the Mizoram Information Commission, the public authorities are required to register themselves in the Portal. Accordingly, the DAA and SPIO of the Commission registered themselves in the Portal. A total of 281 applications were submitted to the SPIO and 13 appeals were filed before the Departmental Appellate Authority.

To summarise the RTI applications and Appeal filed through the online and offline are as below

- 1) No. of Applications submitted to the SPIO 453
- 2) No. of Appeals filed to the DAA 14
- No. of Second Appeals filed to the MIC Nil

All the RTI Applications and Appeals were attended to promptly by the RTI & Record Section of the Office. Appeals filed against the SPIO were also attended to, and all the Appeals filed were disposed by the DAA.

(E) INFORMATION TECHNOLOGY - INITIATIVES & ACTIVITIES

The Commission had been making efforts to make the best use of available technologies in modern development. The major initiatives include the use of IT in the following areas –

- 1) The Commission has its own Official website www.mpscmizoram.gov. in hosted by the Mizoram I&CT Department. In this website, all the important and relevant information had been constantly uploaded to make it user-friendly for the Departments, officials and other public users.
- 2) The Commission has its official e-mail communication system, and various important e-mails were in use for a vibrant and quick communication. Important e-mail communication addresses are as below –

3) Online Application Portal for all recruitments had been in use since the year 2020 and the same is hosted by the I&CT Department. This Portal offers an opportunity for online submission of applications in various examinations conducted by the Commission. The Online Application is linked to a payment gateway through which the applicants can make payment of the required fees.

With the exception of some of the direct recruitments where the applications are required to be submitted in the conventional offline system, all the applications are done through Online Portal of the Commission.

4) The Commission has a separate *Mobile App* for Applicant to various posts, and the name of the App is '*MIPUSEC*' which provides various user services to the applicants.

(F) AWARDS & RECOGNITION TO THE COMMISSION

The Commission had won various awards and recognitions in the past. During the year, the MPSC won the "*First Prize for Official Department Website*" Award for the year 2022-23, and the same was handed over on the occasion of the 'Civil Services Day' on 21st April, 2023.

(G) FIRE SAFETY/AUDIT

The possibility of fire outbreak in a Government Office remains a threat and a challenge for every Office. So is the case with the Mizoram Public Service Commission, and attempts had been made to comply with the standards of fire safety in the Office. Accordingly, in partnership with the Directorate of Fire & Emergency Services, a Special Fire Safety Briefing was conducted in the Office on 22.02.2023. Along with that, a Fire Safety Audit was conducted by the Fire Station, Khatla on the same day. Various recommendations in the Audit were actively pursued for full compliance of fire safety in the MPSC Office buildings.

(H) RECORD & ARCHIVE

The Mizoram Public Service Commission is the custodian of various important documents. These documents relate to various recruitments conducted by the Commission, promotions through DPCs in the Commission, Disciplinary Matters, and various other important documents related to the working of the Commission.

The need for safekeeping of these invaluable documents necessitated the proper safe keeping and stratified recording of such documents for safety and future reference. Thus, the Commission had taken initiatives for listing of such old and important documents, and put in place a system of record-keeping in line with the relevant laws of the Government. Dedicated Rooms for Record are also identified and will be in use soon. This on-going initiative will enable safe-keeping of valuable documents in the Commission.

(I) INFRASTRUCTURE DEVELOPMENT

There is a need for constant improvement and upgradation of infrastructures of the Office Building, Examination Hall and other facilities of the Commission to meet the requirements for smooth functioning of the Commission.

An amount of ₹ 66.46 lakh was allocated by the Government of Mizoram for taking up the works of "Vertical Extension of MPSC Building". The Public Works Department had taken up the work, and completed within the year, and new building was occupied by the Confidential Branch and Deputy Controller of Examinations in March, 2023.

The Government then allocated an amount of ₹ 394.00 lakh for taking up the work of "Improvement and Renovation of MPSC Building" under Special Assistance to State for Capital Expenditure. Implementation of the works had been taken up by the Public Works Department with constant support and monitoring by the Commission. The works had been going on smoothly and is expected to be completed within the time-frame.

Other projects for upgradation and improvement of infrastructures in the MPSC had been prepared in partnership with PWD, and Planning Department. These projects are submitted for consideration of the Government and are kept as pipeline projects.

ACKNOWLEDGEMENT

The Commission would like to place on record its appreciation for the hard work rendered by the Officers and Staff of the Commission.

The Commission also expresses its sincere thanks to the various Departments, Officers and Staff under the Government of Mizoram who extended cooperation and assistance to the Commission in the discharge of its functions during the year.

The Commission also appreciates the assistance extended by various experts associated as Question Setters, Moderators, Evaluators, Scrutinizers as well as the Experts associated in the Personal Interviews conducted by the Commission during the year. The successful functioning of the Commission in matters relating to Direct Recruitments, Limited Departmental Examinations, Departmental Examinations and Promotions during the year was due to the valuable contributions from all of them and is deeply appreciated by the Commission.

The Commission would also like to express its deep gratitude to the Heads of the Educational Institutions for making their buildings and premises and other ancillary facilities available, and for assisting the Commission in conduct of various examinations during the year.

NOTIFICATION

No.A. 12017/2/91 - P&AR(GSW): In exercise of the powers conferred by the provision to clause (3) of Article 320 of the Constitution of India, the Governor of Mizoram is pleased to make the following Regulations as respects to services and posts in connection with the affairs of the State of Mizoram, specifying matters in which it shall not be necessary for the Mizoram Public Service Commission to be consulted.

Short title and commence-ment

- 1. (a) These Regulations may be called the Mizoram Public Service Commission (Limitations of Functions) Regulations, 1994.
 - (b) They shall come into force at once.

Definitions

- 2. In these Regulations, unless the context otherwise requires:-
 - "Appointing authority" means the authority which makes the appointments to any service or post in connection with the affairs of the State of Mizoram;
 - (ii) "Commission" means the Mizoram Public Service Commission;
 - (iii) "Constitution" means the Constitution of India;
 - (iv) "Governor" means the Governor of Mizoram
 - (v) "Service" or "Post" means civil service or post in connection with the affairs of the State of Mizoram.

Limitation 3. of functions in matters relating to methods of recruitment (a)

- It shall not be necessary for the Commission to be consulted in matters relating to methods of recruitment to civil services and posts or the suitability of the candidates for such appointments, in the following cases, namely
 - When an appointment is to be made by the Governor or by recruitment an authority other than Governor to a post on a scale of pay the maximum of which is less than ₹. 2900/- per month.

(b) When it is proposed to appoint a member of a service to a post, for appointment to which the rules of any other service makes a member of other service eligible, and which in the opinion of the Governor, is normally filled by a member of that service or is similar to posts normally filled by a member of that service.

ILLUSTRATION

The appointment of an Officer of the Mizoram Civil Service to the following posts does not require consultation with the Commission: Posts of Deputy Commissioner, Joint Secretary, Deputy Secretary, Under Secretary or Officer on Special Duty in the Secretariat.

- (c) Appointment of the personal staff of the Governor and to his Secretariat.
- (d) Appointment of Law Officers of the State except the members of the State Judicial Service and the Gauhati High Court of Judicature.
- (e) When an officiating appointment is to be made by direct recruitment to a permanent post, if it is necessary in the Public interest that the appointment should be made immediately and a reference to the Commission would cause undue delay:

Provided that, if the vacancy, actual or probable, is for a period of six months or more, the Commission shall, as soon as possible, be consulted in all matters mentioned in clause (3) of Article 320 of the Constitution but not later than the 30th day from the date of issue of such appointment orders.

(f) When an appointment is to be made by direct recruitment to a temporary post, if it is necessary in the public interest that the appointment should be made immediately and a reference to the Commission would cause undue delay:

Provided that if the temporary post has been sanctioned or, is likely to last more than six months, the Commission shall, as soon as possible, be consulted in all matters mentioned in clause (3) of the Article 320 of the Constitution but not later than the 30th day from date of issue of such appointment orders.

- (g) When it is proposed to re-appoint a retired servant of the Government of India or State Government temporarily to (i) a permanent post created in addition to the Cadre of the service from which he retired or (ii) a temporary post created as addition to the Cadre of the service from which he retired or (iii) any other temporary post the duties of which are similar to those normally discharged by members of that service:
- (h) When it is proposed to appoint temporarily an Officer of the Indian Armed Forces to a Civil post or service for a period not exceeding three years;

(i) When it is proposed to make appointment to a post on a contract basis for a period not exceeding three years;

Provided that in case the appointment on a contract basis is likely to exceed a period of three years, the Commission shall be consulted before the contract is renewed or extended;

(j) When it is proposed to make any appointment to an honorary post.

Limitation 4. of functions in respect of promotion

It shall not be necessary to consult the Commission on the principles to be followed in making promotions or on the suitability of candidates for promotion in the following cases:-

- (a) Promotion to a service by an authority other than the Governor;
- (b) Promotion from a lower to a higher grade or post within the time scale of pay provided in the Rules unless the promotion is to be made by selection;
- (c) Officiating promotion for a period which is not likely to last for more than one year;

Provided that if the period of officiating promotion is extended beyond the term for which it was originally sanctioned, the period of promotion shall, for purpose of this regulation, be reckoned from the date when the promotion originally took effect and not from the date of the extension of the period.

Limitation 5. of functions in respect of transfer

It shall not be necessary to consult the Commission on the principles to be followed in making transfer or on the suitability of candidates for transfer from one post to another in the same service.

Limitation 6. of functions in respect of disciplinary cases

It shall not be necessary for the Commission to be of consulted in disciplinary matters in the following cases:-

- (a) in passing an order by any authority other than Governor, whether the order passed is an original, an appellate or a revisionary order;
- (b) by the Governor, when rejecting a petition or memorial;
- (c) in any case in which the Commission has at any previous stage been consulted as to the order to be passed and no fresh question has thereafter arisen for determination.

ILLUSTRATIONS

- (a) The stoppage of an officer appointed by the Governor at an efficiency bar does not require consultation with the Commission.
- (b) an officer is censured by the Governor. It is not necessary to consult Commission before the order of censure is passed;
- (c) an officer is suspended pending an enquiry into his conduct. The Commission need not be consulted before the order of suspension is passed;
- (d) it is proposed to dismiss a State Service Officer or to reduce his pension. The Commission must be consulted before an order is passed by the Governor;
- (e) It shall not be necessary to consult the Commission in any case relating to:
 - (i) the termination of probation of any person;
 - (ii) the discharge of reversion of a person otherwise than as penalty;
 - (iii) the termination of the employment of a person in accordance with the terms of his contract or employment;
 - (iv) the imposition of any penalty laid down in any rule or order for failure to pass any test or examination within a specified time;
- (f) Reduction in pension in a disciplinary case. The pension of an official is reduced by the Head of Department. The appeal is filled before the Governor. The Commission should be consulted before the appeal is disposed of by Governor;
- (g) An Assistant in a District Office is dismissed by the District Officer. He appeals to the Governor. The Commission will be consulted before an order is passed by the Governor.
- (h) An official in a subordinate service is dismissed by the Head of Department. An appeal made to the Governor. It is not necessary for the Head of Department to consult the Commission before dismissing the official. But the Commission should be consulted by the Governor before deciding the appeal;

- (i) An Officer who was dismisse by an original order of the Governor memorializes the Governor against that order. The Commission need not be consulted on the memorial if the order of dismissal was after consulting the Commission.
- (j) An official was dismissed on his appeal rejected by an authority Subordinate to the Governor. He memoralizes the Governor against that order. The Commission must be consulted before the Governor re-instates him but not if the Governor decides to reject his memorial.
- 7. All previous Regulation made on the subject shall stand repealed on and from the date of the commencement of this Regulation;

Provided that any action or actions taken under such Regulations hereby repealed shall be deemed to have been taken under these Regulations.

4. Regularisation of Contract basis

- (1) Regularisation of employees recruited by Mizoram Public Service Commission on Contract basis for Group 'A' and 'B' post(s) under the Government of Mizoram shall be done under the "Government of Mizoram Regularisation of Contract Employees Scheme, 2008" as amended from time to time
