Whereas, the Government of Mizoram, DP&AR(GSW) informed the Commission again that the Committee on Petitions, Mizoram Legislative Assembly revoked its earlier instruction to put on hold the recruitment process for the said post *vide No.A.11019/14/2023-P&AR(GSW) Dr. 29.10.2024;*

Now, therefore, it is hereby notified for information of all concerned that the Commission has revoked its earlier Notification of even *No. Dt.10.04.2024* with immediate effect. Consequently, the Answer Scripts of candidates listed in the Provisionally Qualified list for recruitment to the post of Junior Grade of Mizoram Forest Service (Assistant Conservator of Forests) will be evaluated henceforth.
