Whereas, an Advertisement floated on 21.12.2023 stated that the required Educational qualification to be possessed by a Candidate for the Post of Entomologist under H&FW Department is Master of Science in Zoology with specialization in Entomology, and those who considered themselves to have had possessed such qualifications applied for this Post. Based on their performance in the written examination held during 26th- 28th February, 2024, five (5) candidates were shortlisted on 9.4.2024 for further screening of documents to check if they fulfil all eligibility criteria;

And, Whereas, MPSC requested the Secretary to Govt. of Mizoram, H&FW Department on 2nd May, 2024 to send an expert from the Department on 8th May, 2024 to conduct document screening of candidates shortlisted for the Post, and since no concrete clarification could not be made by the Department's representative that came for screening on 8th May, 2024, an Expert from a reputed Institution was appointed instead on 13th May, 2024 to do the screening work. In the meantime, MPSC issued an Addendum on 22nd May, 2024 in which six (6) other candidates were added, besides the five (5) candidates who were previously shortlisted, and the total candidates identified for document screening had gone up to eleven (11). Expert's findings and recommendations showed that only three (3) candidates amongst them have the qualifications required by the existing Recruitment Rules:

And, Whereas, MPSC is highly cautious in this regard and in order to avoid any possible mistakes, a six (6)-member Review Board with the Secretary, MPSC as its Chairman has been formed to review the qualifications possessed by each candidate afresh, and the Board submitted its findings/recommendations on 7th November, 2024;

Now, therefore, on the recommendation of the Review Board after having a thorough examination on the matter, it is hereby notified for information of all concerned that the following four (4) candidates (in alphabetical order) are called for Personal Interview to be held on **27.11.2024 (Wednesday) at 10:00am** in the office chamber of the Chairman, Mizoram Public Service Commission.
