- (c) Which Section of the Representation of the People Act, 1951 authorizes the State Government for requisition of any vehicle, if it is needed, for any election purpose?
- (d) Does a candidate who completes 25 of years of age on the last date for filing of nominations fulfill the age qualification?
- (e) Who can declare a person as disqualified for not lodging accounts of election expenditures under Section 10 A of the Representation of the People Act, 1951?
- (f) Which section of the Representation of the People Act, 1951 was struck down by the Supreme Court in July 2013?
- (g) By which Constitutional Amendment Act, the voting age of India Citizens has been reduced from 21 years to 18 years?
- (h) Which part of the Constitution deals with the Executive?
- (i) How many Schedules are there in the Indian Constitution?
- (j) On which date is Constitution Day celebrated in India?
