- (c) Define 'Sexual Harassment' under the CCS (Conduct) Rules, 1964. What is the composition of the Internal Complaints Committee for Sexual Harassment?
- (d) What is included in the term 'Movable Property'? Which authorities are designated as the 'Prescribed Authority' for different categories of Government servants?
- (e) What procedures should be followed when a Government servant fails to comply with the provisions regarding the canvassing of non-official or outside influence?
- (f) What is the expected conduct of a Government servant regarding intoxicating drinks and drugs? Define 'Public Place' for the purpose of Rule 22 of the CCS (Conduct) Rules, 1964.
- (g) Describe the restrictions imposed on a Government servant in relation to the acquisition and disposal of immovable property outside India and transactions with foreigners.
- 2. Under what circumstances and conditions can a Government servant accept a 'gift'? (5)
- 3. State whether the following statements are 'True' or 'False':
  - (a) A Government servant does not need permission to approach a court of law to seek redress for grievances related to his service conditions.
  - (b) A Government servant may attend a public meeting organised by a political party under certain conditions.
  - (c) A Government servant is not required to obtain permission to marry a person who is not of Indian nationality.
  - (d) The time limit for granting permission to a Government servant seeking approval for involvement with the press is 50 days.
  - (e) If a government servant enters into a transaction involving movable property, he must report it to the prescribed authority within three months if the value of the property exceeds two months' basic pay.

  - (a) Driving Licence (b) Breath Test
  - (c) Good Samaritan (d) Accident
- 5. <u>Fill up the blanks</u>:
  - (a) As per section 7 (2) of the Motor Vehicle Acts 1988, No person under the age of \_\_\_\_\_\_ yrs shall be granted a Learner's Licence to drive a motor cycle without gear except with the written consent of the parents/guardian.
  - (b) No person shall drive or cause or allow to be driven in any public place any motor vehicle with a left hand steering control unless it is equipped with a mechanical or \_\_\_\_\_\_ signalling device of a prescribed nature and in working order.
  - (c) Whoever, while driving or attempting to drive a motor vehicle has in his blood, alcohol exceeding \_\_\_\_\_\_\_ of blood detected in a test by a breath analyser shall be punishable for the first offence with imprisonment for a term which may extend to 6 months or with fine of Rs \_\_\_\_\_\_ or with both.
  - (d) The driver of a motor vehicle shall drive the vehicle as close to the left side of the road as may be expedient and shall allow all traffic which is proceeding in the \_\_\_\_\_ direction to pass on his right hand side.
  - (e) Driving a Motor Cycle or causing or allowing a Motor Cycle to be driven without wearing a protective headgear shall be compounded with a fine of Rs \_\_\_\_\_ under Section 194 D of the Motor Vehicle Acts 1988 and such person shall be disqualified for holding licence for a period of \_\_\_\_\_ months.
  - (f) No holder of Driving License/Learners' License shall \_\_\_\_\_\_ it to be used by any other person.
