- 15. What is the prescribed minimum and maximum rates of subscription to the Fund? Who shall fix such rates? (2+1=3)
- **16.** Under what circumstances is subscription at less than the minimum rate permissible? (3)
- 17. Choose the correct answers from the given options in the following statements. (10)
  - (a) Apprentices and Probationers are treated / not treated as temporary Government Servants.
  - (b) Major brothers are **included/not included** within the term 'family' for the purpose of GPF Rules.
  - (c) The present rate of interest in respect of GPF is 8%/8.8%.
  - (d) Withdrawal <u>cannot be sanctioned / can be sanctioned</u> even if an advance is being sanctioned for the same purpose and at the same time.
  - (e) The amount of subscription can be reduced **twice/once** during the course of the year.
  - (f) An official under suspension is eligible / not eligible for grant of an advance from the Fund.
  - (g) Year for the purpose of GPF means a financial year / a calendar year.
  - (h) A nomination made by a subscriber **is not valid/is valid** even if the subscriber dies before the nomination reaches the Accounts Officer.
