 - (b) Expenses in connection with an operation for sterilization are **refundable/not refundable** even if it is intended to serve as a measure of family limitation.
 - (c) Medical reimbursement claim should be preferred within 3/6 months from the date of completion of treatment.
 - (d) An advance paid to the official is to be adjusted against the relevant claim and the balance, if any, should be recovered from pay in 6/4 equal installments
 - (e) The duration of treatment for mental diseases can be extended for a maximum period of **three**/ **five** years.
