4. What is the minimum period of imprisonment prescribed for the offender where the contravention involves commercial quantity in relation to psychotropic substance under the ND&PS Act, 1985?(2)
5. How many Special Court of NP&PS Act are presently available within the State of Mizoram. (2)

7. State whether search of the person of female by a male official is permissible. Also state whether search of the person of female by a male official due to non-availability of female official at the time of search can be held lawful where narcotic drug or psychotropic substance was actually recovered from her by the male official. 8. State under what circumstances that suspension, remission or commutation can be given in any sentence awarded under the ND&PS Act 1985. (4)
9. State whether the offence under the ND&PS Act, 1985 is cognizable or not. Also state the limitations prescribed by the Act for granting bail upon the accused where the offences involving is commercial quantity. (5)
10. When are the vital procedures for legalizing conduct of entry and search of premises without warrant or authorisation between sunrise and sunset? (5)

22. State the prescribed procedure in the event of an arrest caused by a private person on any offender of non-bailable and cognizable offence under the Mizoram Liquor (Prohibition and Control) Act, 2014. (4)
23. What are the restrictions laid down under the MLPC Act 2014 towards export, import and transport of liquor? (4)
24. What are the prerequisite conditions for granting bail upon the accused of an offence punishable for imprisonment of 3 years or above under MLPC ACT 2014? (4)
