- 1. State and explain any five statutory exceptions to the offence of defamation. 'A' draws a picture of 'Z' running away with 'B's watch, intending it to be believed that 'Z' stole 'B's watch. Does the act of 'A' constitute offence of defamation? Discuss giving reason. (5+5=10)
- 2. 'To constitute the offence of extortion the will of the victim has to be overpowered by putting him in fear of injury.' Explain. 'A', by putting 'Z' in fear of grievous hurt dishonestly induces 'Z' to sign or affix his seal to a blank paper and deliver it to 'A'. 'Z' signs and delivers the paper to 'A'. Does 'A' committ extortion? Discuss giving reason.
