Date of birth ... 15.4.1956

Date of retirement ... 30.4.2016

Pay & Allowances ... Pay = Rs.12,910/-, Grade Pay= Rs.2800/-

7. Mr. A, born on 01.3.1957 retired on superannuation on 28.2.2017 (AN) while drawing a band pay of Rs. 22,030/- plus Rs.5.400/- GP and Dearness Allowance @ 119%. He died on 05.03.2017 soon after his retirement. Calculate: (6+6=12)

- (a) Enhance rate of Family Pension showing how long the enhanced rate can be paid to his family.
- (b) Normal rate of Family Pension, showing the date from which normal rate of pension shall be paid to his family.
