In continuation of the Advertisement No. 22 of 2016-2017 dt.1.2.2017, the Commission has decided to add the following point to the said advertisement in accordance with Office Memorandum issued by Govt.of Mizoram vide No.A.12018/1/80-APT(B) dt.27.4.1992 and this will come under Sub no.3 of Serial no.6 i.e.'Age Limit':

"Provided that relaxation of 5 years in the upper age limit is admissible to Government servants who have rendered not less than three years continuous service in the same department who are working in posts which are in the same line or allied cadres and where a relationship could be established that the service already rendered in a particular post will be useful for the efficient discharge of the duty of the posts being advertised herein. For Schelduled Caste/Scheduled Tribe candidates, the age relaxation permitted here is in addition to the age relaxation admissible to him as a candidate belonging to Schelduled Caste/Scheduled Tribe".
