- (ii) 10 minutes for reconciliation
- (iii) 30 minutes for typing
- (iv) Maximum permissible errors : 10%

- (B) **Stenographer Grade-III** : (i) 80 words per minute for 5 minutes dictation given by an expert in English Stenography
(ii) 10 minutes for reconciliation
(iii) 30 minutes for typing
(iv) Maximum permissible errors : 10%

Candidates who qualify themselves in the Shorthand Speed test only shall be eligible to sit in the written Examination.
