**Subject : Amendment of Guidelines No. 7 and 17 of Mizoram Public Service Commission(Conduct of Examinations) Guidelines, 2013.**

Consequent upon the decision taken in its meeting held on 10<sup>th</sup> July, 2018 at 2:45 pm, the Mizoram Public Service Commission hereby makes the following guidelines further to amend the Mizoram Public Service Commission (Conduct of Examinations) Guidelines, 2013 and, they shall come into force with immediate effect:

1. Para 2 of Guideline No. 7 shall be substituted as under:

After the last day for submission of applications, the Examination/Direct Recruitment Section shall scrutinise all the applications in minute details. If there is any incomplete application in the nature of non enclosure of necessary documents or non furnishing of crucial informations, 10 days period for rectification of application shall be given to a concerned applicant in writing and, if the concerned applicant fails to rectify his/her application during that period it shall be rejected forthwith. After scrutiny, the Examination Section shall put up the concerned file to the Commission for fixing date of examinations, alongwith a statement showing the number of valid applications and those liable to be rejected.

2. Sub-guideline(g) shall be added under sub-guideline(f) of Guideline No. 17:

(g) Immediately on conclusion of written examination, a period of 3 working days shall be given to candidate who would like to lodge complaint on question or questions of the just concluded examination.
