NOTIFICATION

Dated Aizawl, the 6<sup>th</sup> January, 2015.

No.A.12026/2(2)/2014-MPSC : It is hereby notified for the information of all concerned that for the assessment of each candidate's eligibility for the post of Dental Surgeon (1 post) under Health & Family Welfare Department which is duly notified vide Commission's Advertisement No. 10 of 2014-2015, the following norms shall be adopted in order to give due recognition to additional qualifications, normal Experience and rural Experience:

I. Experience : 1 mark for each completed year of experience subject to maximum of 10 marks

*(In case of broken period, experience more than six months may be taken as one year and less than six months shall be ignored)*

II. Additional Qualification : 5 marks for Post Graduate Degree and 2 marks for Post Graduate Diploma.

III. Rural Experience : The preferential clause of Rule 10 (4) of MHS Rules, 2009 is to be applied only after the selection process is completed i.e. after all the marks are tabulated and if there is a tie between candidates.

IV. In case there is a tie between candidates, only those services of rural area rendered by a candidate under State/Central Scheme/CSS/NRHM etc. operated by the Government of Mizoram shall be counted to break the tie. The concerned department had already clarified Rural Area as 'places outside Aizawl City' vide Notification No. A. 14011/2/2008-HFW/PdI dt. 13.03.2013.

V. Any other Urban or Rural Area service rendered by a candidate will be counted as experience.

The above norms shall be applied for the purpose of recruitment of 1(one) post of Dental Surgeon vide Advertisement No. 10 of 2014-2015 as a one time measure only.
